

A regular meeting of the Tabor City Council was held April 8, 2020. In order to help stop the spread of the COVID-19 virus, this special meeting of the Tabor City Council was held electronically. Chapter 21.8 of the Iowa Code does permit an electronic meeting where all members participate remotely when an in-person meeting is impossible or impractical, which is certainly true during this crisis. On March 19, 2020, Governor Reynolds issued a Proclamation of Disaster Emergency which included a suspension of Iowa laws that would prevent the use of electronic meetings or the limitation on the number of people present at an in-person meeting site. Therefore, only Mayor Switzer, City Clerk Mary King-Bateman and Councilperson Jackson were present at Tabor city hall, 626 Main St., Tabor, IA 51653. The agenda posted as required by law had this message posted more than 24 hours in advance to give instructions on how others could participate in the meeting: Due to the COVID-19 crisis, the City of Tabor will be holding this regular city council meeting electronically via a conference call. If you would like to participate, just before the meeting start time, you must call 339-207-7507 to enter the meeting. Only staff and city officials are allowed in city hall.

The Tabor City Council met in regular session on **April 8, 2020** in council chambers, 626 Main St., Tabor, Iowa at 6:04 p.m. Agenda posted as required by law. Present at city hall were Mayor James Switzer, City Clerk Mary King-Bateman and Councilperson Jackson. Electronically present via conference call were Councilpersons Bartholomew and Wirth. Councilpersons Korver and Williams were unable to attend.

Meeting was called to order by Mayor Switzer at 6:04 pm. Motion to open the meeting by Bartholomew, second by Wirth. Roll call vote: Ayes – Jackson, Bartholomew and Wirth. Absent – Korver and Williams. Motion carries.

Motion to approve the budget amendment and stet the public hearing by Jackson, second by Bartholomew. Roll call vote: Ayes – Jackson, Bartholomew and Wirth. Absent – Korver and Williams. Motion carries.

Motion to adjourn by Bartholomew, second by Jackson. Roll call vote: Ayes – Jackson, Bartholomew and Wirth. Absent – Korver and Williams. Motion carries.
