

The Tabor City Council met in special session on **March 29, 2023**, in council chambers, 626 Main St., Tabor, Iowa at 6:30 p.m. Agenda posted as required by law. Meeting was opened at 6:30 p.m. by Mayor Switzer. Present: Councilpersons Jackson, Williams, Bartholomew, and Korver. Wirth-Absent. City Clerk Mary King-Bateman. Assistant Superintendent Dillon Bartholomew and Library Director Dawn Miller. No visitors.

Motion by Jackson, second Bartholomew to approve the consent agenda. All Ayes. Motion Carries.

Motion by Bartholomew, second Korver to open the public hearing at 6:32 p.m. All Ayes. Motion carries. SWIPCO representative Ashley Hayes announced the funding status for CDBG-DR-15 and 17 Housing. No other public comments or concerns. Motion by Williams, second Jackson to close the public hearing at 6:47 p.m. All Ayes. Motion carries.

Motion by Korver, second Bartholomew to adopt the FY Budget 23/24. Roll call vote: Ayes - Bartholomew, Williams, Korver, and Jackson. Nays – None. Absent – Wirth. Motion Carries.

Motion by Jackson, second Bartholomew to approve the Status of Funded Activities report regarding housing projects 19-DRH-15 and 19-DRH-17 at 624 Center and 509 Sherman. Roll call vote: Ayes - Bartholomew, Williams, Korver, and Jackson. Nays – None. Absent – Wirth. Motion Carries.

Motion by Bartholomew, second Korver to approve R-5-23, A Resolution authorizing the application for the Fire Service Training Bureau Fire Fighting Equipment Revolving Loan Fund, and authorizing the Mayor, and/or City Clerk, to sign on behalf of the city, any documents needed to complete consummation of the loan. Roll call vote: Ayes - Bartholomew, Williams, Korver, and Jackson. Nays – None. Absent – Wirth. Motion Carries.

Motion by Bartholomew, second Williams to approve R-6-23, A Resolution for an agreement between the City of Tabor and the Mills-Fremont rural Fire Protective Association for the purchase of a fire truck. Roll call vote: Ayes - Bartholomew, Williams, Korver, and Jackson. Nays – None. Absent – Wirth. Motion Carries.

Motion by Williams, second Jackson to approve payment on claim #2 for housing projects 19-DRH-15 and 19-DRH-17 at 624 Center and 509 Sherman. Ayes - Bartholomew, Williams, Korver, and Jackson. Nays – None. Absent – Wirth. Motion Carries.

The downtown revitalization grant process was discussed. It was decided that a work session meeting with SWIPCO is necessary to gain a better understanding of this grant requirements before the process can continue. The meeting date and time will be posted at city hall in accordance with open meeting laws.

No action taken for park concession stand repairs. A full discussion on all park improvements is planned for the regular meeting in April.
